Project:	Evaluation of risk associated with different types of wood packaging material – Opportunities to improve ISPM 15 compliance.	
General comments:	Welcoming remarks and review of agenda	
Item 1:	Updates on development of background, category descriptions, and other data sources– All	
Consensus:	<p>Eric developed a background description condensing 10-20 years into a few paragraphs.</p> <p>Action Item: The EG to review to see if they disagree with anything.</p> <p>Meghan’s group did a literature search for ISPM 15 data analyses and provided a summary to be added to the draft S&T document for the EG to review.</p>	
Item 2:	NAPPO MS Teams channel accessibility	
Consensus:	<p>Still some EG members cannot access Teams to share documents. The group considered other options for sharing, such as Google Docs for document creation. Issues regarding government firewalls were discussed.</p> <p>Action Item: Alonso will create a Google Docs folder and send a link for the EG to share materials and develop the Science and Technology document.</p>	

Item 3:	WPM terminology sub-group update	
Consensus:	<ul style="list-style-type: none"> - Leigh noted that there are emerging issues in the US regarding inconsistencies in grouping materials e.g. dunnage and shipborne dunnage. - Inconsistencies in the way data was captured seem to have started in 2019. - EG agreed not to use data that doesn't use ISPM 5 definitions - Brad noted that there is an overall terminology challenge for some categories (not pallets, crates, but things described that are outside of the clearly defined units) - EG agreed to use the categories listed in ISPM 15 - Tyrone noted that we can do some sleuthing to determine the type of WPM based on what commodity it is associated with - EG discussed the difference between dunnage and shipborne dunnage and agreed that shipborne dunnage stays on the ship in all three countries - Arvind noted that in Canada, shipborne dunnage is recognized as having a higher risk; as such, it is recommended to be containerized if remaining on the ship - Faith inquired about the data on risk analysis associated with Canada's new shipborne dunnage program. The decision was based on the literature available.
