	Summary		
Project:	Forestry- Evaluating the risk associated with different types of wood packaging material – Opportunities to improve ISPM 15 compliance.		
General comments:	The meeting focused on updates and progress regarding the project, including harmonizing terminology for wood packaging materials between Canada, the United States, and Mexico. The team discussed ongoing efforts to make WPM terminology and definitions widely available for more accurate data collection. They also noted a recent USDA webinar on wood packaging material, planned future EG meetings and presentations, and confirmed posting of meeting reports on the NAPPO website.		
Item 1:	Updates on terminology and data collection		
Consensus:	 It was noted that CFIA has published definitions for WPM. The categories and definitions align with those recently published by the USDA and include additional terms used in Canada. Efforts are underway to discuss with the border services the potential use of the newly adopted terms and definitions for future data collection. The Secretariat will translate the definitions in the table of the draft S&T document (in the NAPPO Google Docs folder) for colleagues in Mexico. The group also discussed the status of similar efforts in Mexico; there has been progress in contacting relevant departments and organizations for support. 		

	Wood Packaging Production in North America	
	 The team discussed one of the objectives of the EG: to describe the production processes for each type of WPM in North America. The group agreed to start by describing the processes point-by-point, in the three countries, before summarizing the information on a table. For example, the steps for pallets may include obtaining certified materials, building pallets, applying the IPPC HT mark, and ensuring documentation is in place. This was a best-case scenario example, and the group acknowledged that it would be more challenging to include lesser-known processes for other types of WPM. The group considered expanding the comparison to include other countries, for example, those in South America. 	
	Biological Risk The group discussed another of their objectives: a logical and scientific risk assessment of different types of WPM (Action item: Eric and Meghan).	
	 Wood Packaging Origin Data Issues The group discussed the new USDA APHIS wood packaging material dashboard, where data showing the origin of shipments sometimes incorrectly indicates the origin of the wood packaging material. This is a new system, and improvements are being made. There are plans for collecting more detailed data at the border in the future. 	
Item 2:	Wood Packaging Webinar Review The EG discussed a webinar on wood packaging held the previous day, by the USDA on behalf of customs, for educational credits. The recording will be shared with those who missed it (Action item: John Daniels). Project updates and NAPPO Annual Meeting	
Consensus:	 The group discussed the potential of submitting the new WPM definitions for the IPPC glossary. The EG agreed to meet on August 22nd at 2 PM Eastern time.
